STRS

At the October meeting of the STRS Board an Actuarial Valuation as of July 1, 2015 was presented by Segal Consulting. This report is very important because it determines how close STRS is to being fully funded. The Ohio Retirement Council wants all state retirement systems to be at 30 years or less to being fully funded. The report from Segal was that the funding period for STRS was 29.5 years as of July 1, 2014 but according to the report given on October 15, 2015 the funding period has decreased to 28.4 years as of July 1, 2015. This is good news because the goal is to reduce the funding period each year.

John Morrow of the investment department reported on the activity for September 2015. The S&P 500 fell for the second straight month closing down 2.5% for the month. The index is now down 6.4% for the fiscal year. Staff closed the 590 Madison loan refinancing near the end of September. The rate on the new loan is fixed for 10 years at 3.81% interest only, down from 5.46% on the previous loan. The 2016 year to date return for the total fund is an estimated -4.4%. This is the worst first quarter report since 2012 when it was down -8.0%. However, the STRS economic forecast for fiscal 2016 expects U.S. economic growth to move above its long-term potential of 2.5% while growth in private domestic demand heads higher into the mid-3% range.

The finance department reported that the total membership payroll increased for the first time in four years in 2015, The increase of 1.8% was under the actuarial assumption of 3.5% growth. The total number of contributing members also decreased for the fourth consecutive year. The current year reduction in active membership is largely a result of pension reform.

Health Care Plan assets decreased 3.5% to 3.45 billion over the course of the fiscal year as a result of the lack of employer contributions allocated to the health care fund. Program changes, designed to build a long-term financial foundation for the health care program, continue to show results. The changes result in utilization of lower-cost plans, increases in the retiree's portion of premiums and higher generic drug usage. Benefit recipient health care premiums increased as a result of lower subsidies and an increase in retiree health care enrollment. Medicare D reimbursements increased to \$61.1 million in fiscal year 2014 from 46.1 million in fiscal year 2014 due to higher federal reinsurance recoveries.

In the Legislative Report the Ohio House of Representatives and the Ohio Senate approved a much anticipated conference committee report on October 7 regarding charter school reforms. The amendment pertaining to STRS Ohio and the School Employees Retirement System (SERS) followed an attempt in the

budget bill to carve out community schoolteachers working for management companies. A compromise has been reached.

The Executive Director Reported that the Member Education Staff will again present health care openenrollment meetings throughout the state with the first meeting occurring on October 19 in Mentor. As of October 6, nearly 4,400 enrollees had reserved a seat at one of the 57 sessions being offered. Representatives from Aetna and Express Scripts, as well as other health care vendors will be available to those sessions to answer enrollee questions. SERS

Anne Jewel, SERS' director of Health Care Services, presented information on the current status of funding for the Health Care Program. In addition, she discussed factors that could impact future health care funding, including lower investment earnings, the Board Funding Policy revisions, the rising cost of prescription medications, a decrease in Medicare reimbursements, and the upcoming excise tax from the Affordable Care Act. She also reviewed the Board's "Guiding Principles" and the factors used in determining how premiums are subsidized.

After Director Jewel offered an overview of future funding obstacles, the Board restructured the "Guiding Principles" for its Health Care Program. A revised draft of the "Guiding Principles" that includes the Board's suggestions is to be revisited at next month's Board meeting. *Submitted by SERS Observer Adele Matia*

Medicare B Increase Alert

Included in the recent federal budget agreement were changes that impact Medicare B enrollees. As a result of Congressional action by the U.S. House on October 28 and the U.S. Senate on October 30, beginning January 1, 2016, new enrollees and current Medicare B beneficiaries who do not have Social Security (THE MAJORITY OF STRS BENEFIT RECIPIENTS) - and who do not have high incomes - will notice a 14% increase in monthly Medicare B premiums from the current \$104.90 per month to a total of \$123 per month - a premium of \$120 PLUS an additional \$3 per month surcharge. Additionally, the Medicare B deductible will increase from \$147 to \$167 for all enrollees. It could have been much worse. Without the legislation, 30% of enrollees faced a whopping 52% increase in premiums and the deductible was set to increase to \$223.

On October 15, the Social Security Administration announced for only the third time in the 40-year history of Social Security (2010, 2011 and 2016) there will be no COLA increase for SS benefit recipients in 2016. The COLA is tied to the Consumer Price Index (CPI) which has been flat due to lower gasoline prices. The lack of a raise triggers other bad news for some retirees - higher medical costs.

Most Americans have the Medicare B premium deducted directly from their Social Security checks and the COLA increase usually covers any increase to premiums. When it doesn't (like in 2016), a "hold harmless" law protects those roughly 70% of seniors from any increase that would decrease their SS benefit check amount so that they will continue to pay \$104.90.That leaves about 30% of Medicare B participants who do not receive Social Security benefits and are billed for their Medicare Premium to cover the increase that would otherwise be spread among everyone.

Language cited below comes from Senator Portman's office regarding the recently enacted provision for Medicare: This policy would maintain the hold harmless provision in current law and prevent a dramatic premium increase on beneficiaries not held harmless. This policy accomplishes this by setting a new 2016 basic Part B premium for the beneficiaries not held harmless at \$120, which is the amount the Part B premium would otherwise be for all beneficiaries in 2016 if the hold harmless provision in current law did not apply. To effectuate this policy, in 2016, there would be a loan of general revenue from the Federal Treasury to the Supplemental Medical Insurance (SMI) Trust Fund. To repay the loan, starting in 2016, beneficiaries not subject to the hold harmless would pay an additional \$3 in their monthly Part B premium until the loan is repaid. Medicare beneficiaries who currently pay higher income-related premiums would pay higher than \$3, the amount of which would increase for beneficiaries in each higher-income bracket in proportion to income-related premiums under current law. If there is no cost of living adjustment increase for 2017, this provision would apply again.

Close to 70 groups representing seniors and public retiree groups lobbied Congress to pass legislation to stop the increase in premiums for everyone. NEA/OEA were among those groups. I am aware of the following efforts on behalf of Ohio Retirees; I am sure there are many unknown to me. OEA President Becky Higgins wrote letters to the Ohio Congressional delegation on the behalf of OEA-R members. STRS Executive Director Mike Nehf sent letters to each member of the Ohio Congressional delegation relating to the increase in the Medicare Part B premiums for 2016 and its disproportionate adverse impact on STRS Ohio retirees. Additionally the Executive Directors of SERO, PERI and ORTA wrote a joint letter to our

Congressional delegation asking for the same action. On September 30, 2015, I visited the offices of the following Ohio Members of Congress to lobby for this issue among others: Congresspersons Beatty, Gibbs, Johnson, Joyce, Renacci, Stivers and Tiberi. On October 7, Senator Sherrod Brown introduced a bill to keep premium costs and deductibles as they currently are. That language did not prevail. Questions? FCPE: The OEA Fund for Children and Public Education State Council (FCPE), met on August 8, 2015 to screen candidates for U. S. Senate. Those candidates who attended the screening, and filled out the screening questionnaire (requirements for endorsement) were former Congressman and Governor Ted Strickland, and Cincinnati Councilman P.G. Sittenfeld. Senator Rob Portman did not attend, nor did he fill out the questionnaire. However, he did send a letter to thank us for the invitation to screen, and he indicated he had a previous commitment.

After the interviews, the Council voted to recommend the endorsement of Ted Strickland to the NEA-FCPE Council. OEA President Becky Higgins represents Ohio on that Council and delivered that recommendation to NEA during its Superweek meeting the first week in October. On October 2, the NEA FCPE council concurred with OEA's recommendation and Ted Strickland is now the "official" endorsed candidate for OEA. Please be sure fellow retirees are aware of this!
