**Medicare Enrollment and STRS Ohio Webinar:** A common misconception is that Ohio educators do not qualify for Medicare because they did not contribute to Social Security. In fact, you are eligible for Medicare when you turn age 65 even if you are not eligible for Social Security benefits. STRS Ohio requires you to sign up for Medicare Parts A & B or Part B-only at age 65 or earlier if you qualify. During this webinar we will explain the "parts" of Medicare, the importance of enrolling, when and how to enroll, STRS Ohio health care plan options for Medicare enrollees and how to select a new health care plan. We will also address questions often asked by new Medicare enrollees as well as any

questions you submit during the presentation. Each webinar will be held from 1-2 p.m. (EDT) on the dates listed below. Registration for each webinar is limited to 100 people. Registration can be taken until 12:30 p.m. on the day of the session. After you have successfully registered, you will be sent a confirmation email that will include instructions on how to join the webinar. ### SERS

On December 15, the Secretary of State certified that two candidates met the requirements for inclusion on the ballot for a four-year retiree seat term that begins July 1, 2015. Candidates Frank A. Weglarz and Beverly A. Woolridge both met the minimum requirements. All retired SERS members should have received a ballot, a postage-paid return envelope, and candidate biographies with their Focus newsletter by early February. Ballots must be returned to SERS by 4:30 p.m., on March 2, 2015, to be valid.

The auditor determined that the financial statements contained in the SERS Comprehensive Annual Financial Report (CAFR) presented fairly, in all material respects, SERS' net assets as of June 30, 2014. The CAFR contains a detailed look at the System's financial status and investment activities, as well as actuarial and statistical information for the fiscal year ending June 30, 2014. SERS' annual net investment return of 17.3% is a major highlight of this year's CAFR. The return exceeded the policy benchmark by 1.7%. *Submitted by SERS Observer Adele Matias*

## **PROGRAM/SERVICES COMMITTEE REPORT**

The Program/Services Committee is chaired by the OEA-R Vice Chair, Carol Kinsey, as set forth in the OEA-R Guidelines. Other Committee members include Beryl Burkle, Jane Rahn, and Joyce Skocic.

The Committee met four times during each Advisory Council meeting this past year. They reviewed participant evaluations from the OEA-R Fall Conference and the Caucus meetings prior to the RAs in both December and May implementing suggestions within the realm of the committee's responsibilities when possible, e.g. presenters, topics, format/length of sessions, members' needs etc. There was also significant email communication among Committee members regarding the planning of the Fall Conference to gain input and concurrence as the agenda was being finalized.

The committee planned a well-attended Fall Conference presenting the newly elected OEA officers to the attendees as well as focusing on Right to Work and members' interest in health insurance. A recently adopted feature of the Conference where OEA-R members speak to activities in which they participate was again a popular part of the agenda. In response to evaluation comments, door prizes were offered. Based on OEA-R recently affiliating with the Ohio ARA

(Alliance for Retired Americans) and attending their meetings, it was decided to extend an invitation to their Executive Director Headley Davis and their President, Norm Wernet to attend our Conference as observers to learn more about OEA-R. We were honored they made time in their schedules to spend the entire Conference Day with us.

The Program/Services Committee continues to review and revise the Committee's Related Materials as needed. The Program Services Committee is requesting an evaluation of the regional conferences to be shared with the Advisory Council.

### **COMMUNICATIONS/PUBLIC RELATIONS COMMITTEE REPORT**

The Committee met four times this year, in March, May, September, and December. The members of the committee are Bill Sears, Newsletter Editor, Jack Boyd, Webmaster, Bob Beers, and Chris Swank. At each meeting the NEWSLINE, the website, and listserv are discussed along with other topics.

For 2014, the NEWSLINE was available four times this year. The website is used to post relevant information. Copies of newsletters, reports, forms, and photos are available online.

The one major project we have worked on this year is our initiative to "go green". In order to reduce the amount of paper being used, information and reports for the Advisory Council meetings is available to members at a dedicated OEA site. Laptop computers are used by the AC members during the meetings and have proven to be a much more efficient way of handling information. This concept saves money on printing and mailing of the newsletter... There will also be a survey of all members in 2015 to review the items, design, and format.

### OHIO ASSOCIATION OF DEVELOPMENTAL DISABILITIES PROFESSIONALS

The Ohio Association of Developmental Disabilities Professionals (OADDP) was formed in 1983 as a "Department" of OEA serving as a formal caucus for OEA members working in County Boards of Developmental Disabilities. As more and more individuals formerly served by county boards have transitioned to our local public schools, the OADDP has maintained its original focus and stands to support all OEA members working with persons with DD. The Mission of the OADDP is to advance the growth of the education and habilitation of individuals with developmental disabilities and to provide a collective voice for the professional, paraprofessional and support staff working with persons with developmental disabilities. OADDP Strategic Goals promote high standards for staff, provider organizations, and services provided while assuring the viability of County Boards of DD as a service option for those who choose it

### FCPE REPRESENTATIVE POSITION

Names of persons who are interested in serving in the positions of OEA-R Representative and Alternate to the OEA-FCPE State Council are now being accepted. This is a two (2) year term beginning January 1, 2015 and ending December 31, 2017. The elected Representative serves as an OEA-R Advisory Council member in a non-voting capacity and co-chairs the OEA-R Legislative/FCPE Committee. The Advisory Council meets four (4) times a year, usually September, December, March, and May. The Alternate has no required activity except at such time when the Representative may not be available. To be eligible for either position, candidates must meet the requirements of both the Advisory Council and the OEA FCPE, which include a minimum annual FCPE contribution of \$100. The Representative shall represent the interests of the OEA-R to engage in political action to effect the implementation of the OEA policies for the improvement of education in the state of Ohio. Duties may be found in the OEA-R Guidelines Article VIII - Appointments by the Advisory Council Section E. The Guidelines are posted on the OEA-R website, http://oea-r.ohea.us/documents-2/.
