### STRS

As expected the Board made decisions regarding the proposed changes in the STRS Health Care Program. The following changes were approved by the STRS Board taking effect in January of 2017.

#### Medical

- Discontinue Alere disease management program
- Increase emergency room copay for Medicare plans from \$65 to \$75
- Move Medical Mutual non-Medicare enrollees residing outside of Ohio to a Basic Plan administered by Aetna
- Increase urgent care copay from \$35 to \$40 in all plans
- Discontinue HealthSpan Plans

#### Prescription

- Discontinue coverage for proton pump inhibitors (PPI's), all available over-the-counter (examples are Nexium and Prilosec)
- At retail, adopt preferred network with \$10 additional copay at non-preferred pharmacies, and narrow retail network for Medicare
- Discontinue the diabetic 1/2 copay program
- Increase specialty drugs coinsurance percentage from 10% to 13% and per prescription maximum from \$500 to \$550

#### Eligibility Changes

- Discontinue Medicare Part B reimbursements for named survivors and beneficiaries who were age 65 by 2008 and either already a beneficiary or named beneficiary by 2008
- Discontinue sponsored dependent for unmarried retired teachers
- Change dependent children rate to a per child rate

#### Subsidy Changes

- Reduce STRS Ohio non-Medicare subsidy multiplier from 2.1 to 1.8 per year of service
- Phase-out Medicare Part B reimbursement over 3 years; reduce by 1/3 (to no less than \$29.90 minimum until completely discontinued in the third year)

During the May and June Board meetings there will be a review of 2017 Health Care Program Premiums.

John Morrow reported that investments were a plus 4.3% for the month of March. That leaves STRS at a negative 0.6% for the fiscal year with one more quarter to go in the fiscal year. There was a presentation by the International Equities Asset Class managers staff. More information was provided on the actuarial assumptions and the effects they will have.

Executive Director Mike Nehf reported that benefits counselors began calling 350 health care enrollees who are only enrolled in Medicare Part B while having a spouse who is enrolled in Medicare Part A. Unless the enrollee has been married for less than one year, he or she is eligible for free Medicare Part A. Counselors are making outbound calls to explain to the enrollee that free Part A is available and the steps that need to be taken with Social Security. In addition, counselors provide the member with a letter verifying STRS Ohio income so the member can also apply for potential spousal benefits with Social Security. These individuals are a subset of the 12,000 Part B only

enrollees with spousal Medicare information on file. Health care costs will be decreased by about \$1.4 million per year if these individuals are enrolled in Medicare Part A.

Employers are required to submit deposit and service reports for retiring members to confirm final earnings and service credit. STRS Ohio sent 413 reports to employers in the beginning of April for June retirement applicants. This is more than an 80% decrease from last year's number of 2,529 reports. Two years ago, STRS Ohio sent 1,427 deposit and service reports in the beginning of April for June retirement applicants. Reports for members retiring in July and August will be sent to employers over the next two months.
