Welcome Back, EDUCATORS!

Another school year is here and it is going to be an important one. At our August 2017 meeting the **OEA Board of Directors** voted to establish the following "conditions of satisfaction" concepts to monitor OEA's progress on each of our strategic priorities. Conditions of satisfaction are data indicators and are not intended to describe all of the work happening in the priority areas.

Priority 1: Building Locals'

Asks

With Governor John Kasich's signing of his final biennial budget on June 30, Ohio's school districts now have certainty over the level of state funding they will receive during the next two years. With state revenues falling significantly below projections, funding for K-12 education will increase less than 2% over each of the next two years. The budget impact varies widely among districts, although the House and Senate did reduce the number of

districts facing cuts over the next biennium. The OEA succeeded in protecting students and families—and preventing future threats to education funding—by helping to win support for a veto of a Medicaid expansion cap that threatened access to healthcare for 500,000 Ohioans.

OEA was successful in staving off several harmful proposals introduced at different stages of the budget process and in winning important revisions in state law that will help our members and students. A plan to require teachers to complete "externships" in the business community was defeated in the House and excluded from Senate consideration due to extensive member activism. Also removed from the budget were threats to collective bargaining rights in the form of restrictions on severance and retirement incentives for K-12 employees and reductions in sick leave for higher education faculty and staff.

As OEA management and staff work to implement work necessary to meet the priorities that we have established on your behalf, the Board will be monitoring our progress in by the measuring how OEA and our locals are meeting each of the conditions of satisfaction.

Our purpose is to ensure OEA is as strong as possible in meeting the needs of our members and strengthening the cause of students and public education.

More importantly, OEA made significant progress in winning a reduction in testing, helping to avert a graduation crisis, and improving charter school accountability. Two state tests, the 4th and 6th grade social studies assessments, will be eliminated next year. OEA continues efforts for the adoption of new alternative pathways to graduation for the Class of 2018 and will

continue to lobby for a long-term change in graduation requirements to reduce the impact of high-stakes testing on Ohio students.

Significant Changes Come To RESA

Ohio Department of Education (ODE), in response to feedback from OEA members and educators from across Ohio, has made the following changes to the Resident Educator program:

- * The Resident Educator Summative Assessment (RESA) will consist of one task. That task will include a video-taped lesson and 10 – 12 related questions to which candidates will respond.
- * The areas eliminated from RESA (student assessments, communication, and professional growth) will be completed through activities that are developed and delivered locally.
- Educators who complete RESA will receive more constructive feedback on the new task.
- The Resident Educator Program will remain a four-year program. Resident Educators will continue to complete mentoring activities during years one (1) and two RESA during their third year of teaching. Teachers will (2), and will take the continue to become eligible for a professional teaching license after passing the RESA, and completing a fourth year of the program focused on locally-determined leadership activities as well as mentoring activities.

For Resident Educators who have not yet passed all portions of the RESA, the Ohio Department of Education will be sending an email alerting them to the program changes.

*OEA continues to work with the ODE and legislators to make changes to the RESA program.

The 2018 elections in Ohio will have a profound effect on the state's future. control the redistricting and getting as many OEA members as possible to participate in the Fund for Children and Public Education (FCPE) is critically important. The 2018 general election will determine not only who

becomes our next Governor, but who will process for the Ohio General Assembly. In addition, the re-election of our good friend Senator Sherrod Brown will also be vitally important, particularly in light of who currently holds the reins of power in

Washington. Strong participation in OEA-FCPE by our members will enhance OEA's political and legislative advocacy programs and put us in a better position to shape the future of public education for Ohio's students.

STRS Ohio's Total Fund Returns 14.29% for 2017

At the May meeting of the STRS Board, staff presented preliminary 2018 premiums for STRS health care plans. Due to lower than expected health care claims, the 2018 premiums are not expected to increase by very much. For a retiree who is Medicare eligible with 30 or more years of service, the preliminary premium increase was \$129 a month, an increase of \$2. For a

retiree under age 65 with 30 or more years of service the preliminary premium is \$399, an increase of \$19. The STRS Board is expected to approve premiums at the June meeting.

At its June meeting, the STRS board elected retired teacher member Robert Stein as its vicechair for the coming year. According to Board Policies, contributing teacher member Mark Hill (Worthington City Schools), who is currently serving as vice chair, automatically moves into the position of chair. Stein and Hill will assume their new responsibilities on Sept 1, 2017.

Board members receive no compensation for serving on the board other than reimbursements for actual, necessary expenses.

Janus v. AFSCME – Friedrichs Part II

This year the Supreme Court is expected to hear Janus v. AFSCME. This is another Friedrich's like case that will challenge "fair-share" fees. If the Supreme Court rules against unions, as many expect, fair-share fees may soon become unconstitutional.

The case provides us with an opportunity and responsibility to talk with our colleagues about the value of membership in this association. Here are three key themes:
