## STRS REPORT

At the OEA-R Delegate Assembly, Mike Nehf, Executive Director of STRS Ohio addressed the delegates. At that time he handed out an Actuarial Update for STRS Ohio. It is a concise version of what the actuaries provided the STRS Board in October. He did not go over the information at the time but he did encourage the delegates to read the information and then ask any questions they may have about it when he sees them again at the Spring RA.

At the December meeting John Morrow reviewed the October and November Investment Returns and Activity. The total fund return for October was -4.1%. U.S. and International Equity markets declined over 7%. That had been the largest monthly decline in over seven years to that point. The staff initiated significant activity in the midst of the volatility. Approximately \$1 billion was withdrawn from fixed income. \$575 million was allocated to domestic equities. Another \$350 million was allocated to international equities and another \$100 million was allocated to alternative investments.

The total fund for November was +1.0%. Despite positive return, volatility continued during November. The total fund fiscal yearto-date finished at +0.2% and investment assets were about \$76 billion. For December the markets were sharply lower. Trade tensions need resolution soon to prevent deeper impact on economic conditions and market returns.

Callan reported that for the one-year ending 9-30-18, STRS Ohio outperformed the benchmark by 76 basis points and ranked at the 14th percentile of the Callan Public Fund Sponsors Database. In Callan Reports the 1st percentile is best and 100th percentile is the worst. For the five-years ending September 30, 2018, STRS Ohio posted an annualized return of 8.98% relative to the 8.66% of the total fund target. STRS Ohio achieved a return that ranked at the 9th percentile during the last five years.

CEM Benchmarking provided a report of STRS Ohio's Cost Effectiveness Analysis for the five-year period ending December 31, 2017. The key takeaways of this report were as follows: \*STRS Ohio's five year total return of 10.1% was in the top decile of the U.S. public universe. This compares to the U.S. Public median of 9.0% and the peer median of 9.0%. STRS Ohio's investment cost of 40.4 basis points is below our benchmark of 50.3 basis points. This suggests that our fund was low cost compared to our peers and our fund was low cost because we had a lower cost implementation style and we paid less than our peers for similar services.

This benchmarking report compares our cost and return performance to the 293 funds in CEM's extensive pension database. 162 U.S. pension funds participate. The median U.S. fund had assets of \$9.6 billion and the average U.S. fund had assets of 23.5 billion. Total participating assets were \$3.8 trillion. 77 Canadian funds participated with assets totaling \$1.4 trillion. Forty-three European funds participate with aggregate assets of \$2.9 trillion. Included are funds from the Netherlands, Norway, Sweden, Finland, Ireland, Denmark and the U.K. 8 Asia-Pacific funds participate with aggregate assets of \$1.0 trillion. Included are funds from Australia. New Zealand. China and South Korea.

The most valuable comparisons for cost performance are to our custom peer group because size impacts costs. The peer group for STRS Ohio includes 17 U.S. Public Plan Sponsors ranging in fund size from \$48 billion to \$350 billion. The median size is \$94 billion versus our \$78 billion. Our fivevear policy return of 10.1% was above the peer median of 8.8%. Our investment costs were \$267.9 million or 35.7 basis points in 2017. Our total investment cost of 40.4 basis points was below the peer median of 55.4 basis points. Benchmark cost analysis suggest that, after adjusting for fund size and asset mix, our fund was low cost by 9.9 basis points in 2017. Our fund was low cost because we had a lower cost

implementation style and we paid less than our peers for similar services. According to CEM Benchmarking had our funds that were internally managed been managed externally and had we paid the peer median costs, our costs would have been higher by approximately \$95 million.

At the December meeting of the STRS Ohio Board a Health Care Plan Management Policy was adopted by the Board. The goal of this policy is to maintain a sustainable long-term benefit while making adjustments as conditions allow. The primary objective is to maintain an estimated 50% chance that the plan will remain solvent for 60 years or more. Another objective is to share gains and losses between pre-Medicare and Medicare groups.

There was no scheduled STRS Ohio Board Meeting in January. Our next meeting will be February 21st. The Board was presented with information from the actuary concerning the COLA. There was no review of the information at that meeting. The Board will take that information into consideration when it reviews its current fund investment policy. That will be done in the spring.

The Audit information was good and the report can be found on the SERS website.

SERS employees contributed coats, gloves, scarfs and hats for Cristo Rev High School and other community agencies such as the Salvation Army Angel Tree Drive and a "Cookie Extravaganza" to fund Toys for Tots. Carol Nolan Drake, SERS's federal government relations consultant briefed the Board on health care and pension issues tackled in 2018 and what to watch for in the coming year. There were 161 active members that were approved for service retirement and 11 survivor benefits for spouses and dependents.


## Southwestern
