Despite the challenging times we are all experiencing right now, the OEA Board of Directors did meet this past weekend via phone conference. I logged in at 9:15 AM and we adjourned at 2:35 PM. It was a productive day of Association work BY our members FOR our members!

Please note below the action taken in response to the most frequently asked question right now which is----will there be a Spring OEA RA.

13. Authorized the OEA Officers to postpone and/or call a Special Session of the 2020 Spring Representative Assembly.

There will be no "in person" OEA RA. No definitive alternative plan has yet been determined but the officers are working with NEA on the logistics of holding an abbreviated (limited agenda of necessary items only) virtual or call in RA format (Special Session) possibly on May 9---no date selected yet. There are many details to work out. The change from an 'in person RA" to a different form of RA will also impact the planned fundraiser for the OEA Educational Foundation. The Foundation Board will be having a virtual meeting next week to determine other fundraising strategies. OEA-R member Becky Higgins is the Chair of the fundraising committee and I also serve on the Foundation Board. You can always offer your support by making a direct personal contribution by sending a check payable to The OEA Educational Foundation.

At this time OEA is in complete compliance with all health-related directives from Governor DeWine and Dr Amy Acton. Both Headquarters and all Field Offices are closed with officers and staff working from home. Communication with staff and officers continues as in the past. Leadership Council meetings are also cancelled.

For active members, OEA dues only will be reduced by \$9.00. OEA dues are automatically based on a formula connected to the Ohio average teacher salary and can fluctuate up or down each year based on that salary with no action required by OEA. The average Ohio salary has been reduced therefore; the dues decrease. Beyond that (from below)

4. Repealed the action of the 2001 OEA Executive Committee to add a \$20.00 surcharge to the UniServ service fee.

Consequently, ACTIVE member dues will decrease by \$29 total for the 2020-2021 school year with the \$20 Uniserv surcharge removed.

We also filled a Manager position for OEA at this meeting.
