At the beginning of the meeting Kevin Rohrs of ClifftonLarsonAllen presented his findings that resulted from the most recent audit of STRS Ohio. According to ClifftonLarsonAllen the financial statement disclosures are neutral, consistent and clear. STRS Ohio has been presented with a clean audit.

In Bill Neville's Executive Director's Report for November, Mr. Neville reported that STRS Ohio had received the Public Pension Standards Award for Funding and Administration for 2020 from the Pubic Pension Coordinating Council. The award recognizes public pension plans that meet key standards in several assessment areas, including actuarial, audit, benefit programs and communications. In his December report he stated that more than 102,000 retirees received a health care rebate in their December benefit payments totaling \$29 million.

The Board approved the Semiannual Broker Evaluation and Associated Policy. Our consultant Callan, recommended that the policy be approved. There had been several questions raised by two of the appointees on the Board concerning the benchmarks used for the asset classes and the total fund over the past couple of months. Callan and Cliffwater presented an extensive review of the benchmarks employed by STRS Ohio. They made the following recommendations. For all of the asset classes except one Callan recommends that the currently used benchmarks be maintained. For the Opportunistic /Diversified Asset Class Callan presented three options that STRS Ohio might consider. They suggested that the third option might be the best to consider. The third option incorporates a new private markets benchmark at the asset class level for Private Equity and O/D. This benchmark will best reduce the tracking error when incorporated into the Total Fund benchmark to represent the asset classes. At the February Board meeting the Statement of Investment Objectives

and Policy for STRS Ohio will be presented to the Board with any recommended changes the staff sees as beneficial for approval.

John Morrow, Chief Investment Officer, for STRS Ohio reported that as of November 30, 2020 the fiscal year to date returns were 12.4%. Those are very good returns but we know what happened in February of 2020, so we have to hope that these positive returns continue through June 30, 2021.

Lynn Hoover, Chief Financial Officer for STRS Ohio, and Brian Grinnell gave a presentation to the Board to explain STRS Ohio's Unfunded Liability from 2000-2020. The key takeaways of the presentation were as follows: *The Unfunded Accrued Asset Liabilities increased from \$4.5 billion to \$22.3 billion from 2000-2020.

- The primary driver were investment returns being less than assumed, even though returns closely tracked the market
- Total contributions were insufficient to cover the tread water cost; both contribution rates and benefits are fixed
- Other experience was less favorable than assumed, including mortality.

We must take into consideration that in the Great Recession STRS Ohio suffered a significant loss as everyone who had money in the market did during that period. It takes time to recoup those losses.

There were several policy changes that Mr. Steen presented to the Board at 8:00 A.M. that he wanted to be considered at Thursday's meeting. There was a motion by the newly appointed member to table these items and consider them at the February meeting. At first glance these are significant policy changes and deserved more in depth consideration.

At this time I want to wish everyone a holiday season that is safe. Hopefully 2021 will be much improved over 2020. Thanks to everyone who has been working so hard on my behalf to secure valid signatures for my petitions. I so appreciate all your efforts. Please take care of yourselves and keep patient just a bit longer. There is light at the end of the tunnel.

CHAIRPERSON'S REPORT

This past year the Advisory Council developed a new logo for OEA-R, printed new brochures for membership drives, purchased materials for table displays at District and State meetings and pens to hand out at those meetings. We also purchased pins for our delegates and leaders so they can be easily recognized at OEA functions. These materials allow us to be ready to move forward with an aggressive membership drive when the pandemic ends.

The Advisory Council has worked hard to stay in touch with members and continue to encourage member engagement even during the pandemic. We have been challenged to learn new ways to communicate and are learning to be Zoom

proficient. The Advisory Council and committees have continued to meet via Zoom. Several OEA-R members have been placed on NEA-R Committees.

Last spring, the Advisory Council decided to postpone the Delegate Assembly due to the pandemic in order to protect the health of our members. After participating in several large meetings online last year, we were able to plan this Delegate Assembly as a virtual meeting. The Advisory Council is extremely proud of the work accomplished by our members during the election. Many of our members were very involved in the GOTV efforts, as well as working for candidates during the election. We had members using HUSTLE, writing postcards, dropping literature, and making phone calls. Other members worked the polls on election day. We were very pleased with the participation of so many of our members in the TelaTownhall just for retirees about engagement in the election process. We are extremely proud of and grateful for the participation of so many retired members.

The Advisory Council will be supporting Rita Walters' reelection to the STRS Board. Rita is currently the Chair of the STRS Board. She has worked tirelessly on our behalf, and now we need to support her by getting the required signatures for her to be on the ballot and then working with our members to get out the vote.

Discussion is still moving forward on a pre retired prepayment plan for lifetime dues for OEA-R. The discussion was postponed last spring due to Covid and the closing of the OEA building but will be revisited in January. The Advisory Council has been very pleased with the cooperation and support of the OEA officers and the OEA Executive Director, as we have moved forward with this and several other projects.

At our December meeting we seated two new members to the Advisory Council, Julia Basham as the Higher Education Representative and Kathleen Purdy as the ECOEA-R District Representative. Both won by acclamation during our October election.



2020 DECEMBER OEA-R DELEGATE ASSEMBLY REPORT



The 42 delegates representing OEA-Retired to the OEA Fall Assembly met from the comforts of their own homes via Zoom Friday December 4, 2020. Though to a person delegates continued throughout the meeting to defy the adage "you can't teach an old dog new tricks" with their easy transitions to virtual meetings, at the end of the meeting no one was heard to mutter, "You know, I could get used to this."

Delegates heard remarks from a number of guests. First, STRS Executive Director William Neville reported, using a slide presentation, that STRS has processed 992 retirement applications so far this year; last year at this time there were 418 applications. STRS is near to a ratio of about one retiree for every active member in the system. In fiscal 2020, STRS collected \$3.4 billion in member contributions, and paid out \$7.1 billion in pensions and \$490 million in health care benefits. STRS stands at @\$78 billion in assets, and we need a 5% return to keep everything going. Investment return took a dive in February and March 2020, ending at -5.7%. However, it experienced a strong recovery, finishing in June with +3.14%, and this recovery continues. Through November investment return is up @12%. The five-year return of 6.91% outperforms our benchmark of 6.6%. As of now our funded ration is 77.4%. We face a 29% chance of dropping below a 50% funded ration in the next ten years.

OEA President Scott DiMauro reported that schools are not immune from the COVID spike. Even though there is no evidence that schools are sites for virus spread, and without question schools have done a remarkable job keeping their buildings, students, and educators safe from the virus, OEA will issue a Call to Put Education First! In a four-part position paper, OEA will call for a **hard reset**, an immediate cessation of in-person teaching and schooling until at least January 11, 2021, when more is known about the dramatic surge in positive

cases, hospitalizations, and deaths from COVID. OEA proposes to hold accountable county and state health departments and directors to show, using specific data, that schools are safe to reopen whenever that decision is made, and that all relevant collectively bargained conditions are maintained for teachers and members. President DiMauro affirmed that all STRS members want to see a return of COLA, and we're sympathetic to the lessening benefits coming to new retirees. But President DiMauro also noted the necessity of maintaining the long-term viability of our system. Bigger threats to STRS are threats to Defined Benefits, Social Security and Medicare. OEA will continue its work to get rid of GPO-WEP.

OEA Vice-President Jeff Wensing thanked retirees for all they did in the recent elections. He congratulated Mary Binegar on running such a tight race for State Board of Education in a heavily Republican district. VP Wensing reported on the progress of HB 305, the Cupp-Patterson School Funding Bill, which has passed the House 84-8. There are roadblocks in the Ohio Senate, and we need to contact our senators to urge passage of SB 376 (the companion bill to HB 305). The connection for immediate political action is on the OEA Web site (ohea.org). Keep watching for more action alerts. The OEA Board endorsed incumbent Carol Carrouthers for the active seat on STRS Board, and Rita Walters and Rob Stein for the retiree seats. FCPE Chair Tom Moscovic reported that from September 1 to December 1 OEA retirees contributed \$2416.25 to the Fund. Tom advised we need to keep giving! The goal for retirees is to increase our contribution by 2%.

Chair Mary Binegar reported that OEA-R has been busy in its Rebranding program, the results of which we have all begun to see with the new OEA-R Web site (www.ohea.org/retired). New recruitment brochures have been produced and are ready for distribution as soon as we can all get back on the road. Beginning February 2021 OEA-R will begin an energetic campaign to recruit new members, both pre-retired and retired applicants. Another important task is to get our two members re-elected to the STRS Board! Gathering signatures on nominating petitions is difficult during COVID; Mary noted that petitions have been shared across the state with various OEA-Retired Advisory Committee members as well as other retired volunteers. We need to download those petitions, sign them and return them via US Mail to both Rita and Rob! Better yet, if we live with an STRS recipient, and/or in a neighborhood with fellow recipients, we can try to safely gather those signatures too! AND! We need to vote once we receive the ballots!

Various other reports, including the OEA-Board report, the Legislative Committee Report, the OEA-R Budget Report, and the Audit Committee, are available on the OEA-R web site.

Two New-Business proposals submitted by John Hoyes on behalf of the Membership Guidelines Committee, having to do with removal of OEA-RAC members and officers, and length of terms of service for positions, were

discussed and ultimately postponed and/or referred back to the committee to resolve various issues.

DECEMBER 2020 OEA REPRESENTATIVE ASSEMBLY REPORT

President Scott DiMauro called the virtual Assembly to order at 9:00 AM on December 5, 2020. He paid honor to past OEA President Murl Huffman(WOEA) who passed away earlier this year at age 101. Murl was very influential in establishing collective bargaining in the state of Ohio and will be remembered for his long support and advocacy for public education. The 677 delegates were reminded by President DiMauro about the impact the pandemic has had on educators and students and how OEA has continually fought for the safety of members and students. Attendees heard from NEA President Becky Pringle. OEA-R Chair, Mary Binegar, particularly noticed the comment, "We need to acknowledge our power. We need to stand in our power. We need to act like the largest union in the United States." As always, Becky was inspiring and uplifting for educators. Jeff Wensing, OEA Vice President, discussed all the legislative undertakings in the Legislature and how they affect OEA members. He also announced that the OEA Board endorsed Rita Walters and Robert Stein for the STRS Board retired seats. Judy Novak represented OEA-R for the screening. Endorsements were made for the SERS retired seats for Barb Phillips and Frank Weghlarz. Barb Catalano and Cindy Endres represented OEA-R.

The new OEA Executive Director, Patricia Collins Murdock, was introduced and outgoing Executive Director, Sheryl Mathis, was thanked for her many years of service to OEA. Sam Radel, OEA-R, was appointed to the OEA Appeals Board.


Barb Armour, ESP of the Year and Leila Kubesch, Teacher of the Year, addressed the delegates.




when in person reading is permitted. The books are currently boxed by District with ongoing discussion about distribution. Each book has an OEA-R bookplate.

The grant committee has been meeting since NEA-R approved our grant in mid-October for the 2020-2021 year. This year's grant focuses on the following four goals.

- Goal 1 Align the state affiliate goals and mission with our district retirement groups to keep our retired members informed and engaged in all aspects of OEA.
- Goal 2 Develop leadership skills of retired members by encouraging and enlisting more participants in retired activities.
