Recognition of and remarks from Guests:

STRS - Rita Walters - her report is posted on the OEA-R website

- John Morrow, the Chief Investment Officer and also the deputy executive director, will be retiring after 31 years of service.
- Matt Worley will become the new Chief Investment Officer.
- Executive Director Bill Neville reported that new retirements are up this year- 688 in March; the number of applications received this year was highest since 2015– STRS Ohio is on pace to have 4000 retirements this fiscal year

President of OEA - Scott DiMauro

- We have 4 new business items and 2 resolution amendments being submitted along with a Constitution & Bylaws proposal at the OEA RA on Saturday.
- Scott will highlight 1 New Business Item along with a formal recommendation of the board that is to take a strong proactive step in asserting our role as educators as the voice as critical decisions are being made about to how to spend 4 ½ billion dollars coming into the state of Ohio as the result of President Biden's American Rescue Plan Act.
- Scott also talked about the Fair School Funding Plan which brings tax dollars home to local communities and fixes school funding and we can do it right now with <u>zero</u> tax increase.
- The better off schools are in terms of funding, the stronger the retirement system
 is because we have stable contributions coming into the system and we are able
 to hire more into the system.

Vice President of OEA - Jeff Wensing

- Talked about HB 200 and SB 145- revise the state report card and school accountability
- Rebranding OEA fund. No longer call FCPE but call OEA Fund.
- Jeff will give a full report on Fair School Funding Plan and American Rescue Plan and other legislative information on Saturday.

Secretary-Treasurer - Mark Hill

- Mark also talked about American Rescue Plan and the Fair School Funding Plan
- Membership is slightly down under about 2% or about 1900 members.
- Mark also mentioned about OEA-R pre retired prepayment plan
- Thank everyone for their help in the STRS board elections

- Legislative support for:
 - Reopening Rebuild America's Schools Act improve public school facilities across the country
 - Equality Act provide protection from discrimination for LGBTQ students and educators
 - o Provide healthy school meals
 - For the People Act would strengthen voting right and push back on voting suppression efforts

Presentation of NEA-R Grant – Judy Buschle - online

- Goal 1 Align the state affiliate goals and mission with our district retirement groups to keep our retired members informed and engaged in all aspects of OEA.
- Goal 2 Develop leadership skills of retired members by encouraging and enlisting more participants in retired activities. Through implementation of the grant, opportunities in the districts such as "Read Across America Project" targeting diversity and in attending various activities in district workshops, trainings and conferences.
- Goal 3 Each of the 10 districts will work with Ohio's O.N.E. (Ohio New Educators) Member Ambassadors to strengthen the relationship with state affiliate and local leaders.
- Goal 4 To work with O.N.E. Member Ambassadors in making early contact with new aspiring educators, using technology that acknowledges and welcomes them to the profession of education

through a buddy system. Establishing early contact and setting up systemic checks with new aspiring educators will help them have someone to express their needs and frustrations in a safe and secure venue.
