Mr. Matt Worley reviewed the Performance-Based Incentive Compensation Program (PBI) for 2022, the program was approved by the Board. Of the 515 associates that the system employs there are only 92 that while saving over \$100 million due to in-house management of investments. Mr. Worley reported that April was another good month for investments. Preliminary fund returns for April were +2.80%. Year-to-date the STRS Ohio fund has earned 24.35% returns. Total investment assets ended April at \$91.8 billion, higher by \$14.8 billion in fiscal 2021.

Mr. Neville reported that voting in the 2021 Retirement Board election for one contributing member seat and two retired member seats concluded on May 3. An independent third-party firm, Election Services Company, certified the election results at the board of tellers meeting on May 8. Carol Correthers was elected to the contributing member seat, while Rudy Fichtenbaum and Robert Stein were elected to the two retired member seats.

Executive Director, Bill Neville, reported that member education staff introduced the new Retiree Series webinar Basics of Online Account Access in April. This program provides an overview of Internet basics and how to access STRS Ohio Online Personal Account features and resources. The new series is being in May. Sponsored by STRS Ohio, a representative from the attorney general's office will discuss how to secure devices, safeguard personal information and avoid cyber scams. Additional webinars will take place in August and December 2021.

STRS Ohio received 739 new Service Retirement Applications in April, representing a 55% increase over April 2020. Fiscal year to date, STRS Ohio has received 3,100 applications, compared to 2,200 for the same period last year and about 2,500 in fiscal 2019.

In a report from Cheiron, STRS Ohio's outside actuary, STRS Ohio conducts experience studies every 5 years and the next one is scheduled after the 2021 valuation. The following factors are considered during this study: historical experience, industry trends, regulatory/professional standards, Board's risk tolerance/preference, plan dynamics, and future expectations. Cheiron recommends that STRS Ohio adjust its discount rate from 7.45% to somewhere in the range of

6.25% and 7.00% for the June 30, 2021. The Board will consider that recommendation at the June Board meeting.

The STRS Ohio Board approved the following motion for changes in the healthcare program for 2022:

Move to Express Scripts' National Preferred Formulary for non-Medicare enrollees and the Premier Performance Formulary for Medicare enrollees,

Reduce specialty co-pay to lesser 8% of cost or \$450 from the lesser of 13% of cost or \$450 per 31-day supply.

Decrease drug maximum out-of-pocket limit to \$5,100 from \$6,550 for the Medicare plans, below the 2022 standard Part D limit of \$7,050.

The Board also approved the following motion to suspend the methodology adopted by the Retirement Board in May, 2015 of setting the self-insured prescription program annual deductible to 63% of standard Medicare Part D deductible limit rounded down to the nearest \$25 increment, and maintain the current 2021 deductible for plan year 2022.

The STRS Ohio will approve the healthcare rates for 2022 at the June meeting. If the projections remain the same the proposed 30-year benefit recipient would be pay a monthly healthcare premium of \$112 instead of the current \$127.

The Board also voted to offer the position of Chief Auditor to Robert Vance to replace Dave Tackett when Dave retires on July 30, 2021.

# **CHAIRPERSON'S REPORT**

#### Mary's thoughts-

This has been an extremely interesting year but also extremely productive year for OEA-R. Because of the willingness of our members to find a way to make things happen even during a pandemic, we have made great progress this past year. We were extremely involved in the November elections and then again in the STRS Election in April. Our members wrote and mailed postcards, made phone calls, and sent texts and emails to fellow OEA members regarding these elections. We held an Election webinar with approximately 200 participants and a Retirement webinar with 65 participants.

In addition to these activities we also launched our new pre-retirement pre-payment plan for lifetime OEA-R membership. This will allow active members to spread their lifetime dues over multiple months. Our hope is this will encourage more people to join OEA-R while they are still active members.

Additionally, our district representatives have been reaching out by postcards or phone calls to our oldest members, beginning with those who are 90 or over. According to our records we have over 600 members that are 90 or over. The responses to these postcards have been extremely positive, and I am extremely appreciative of the work of our district reps for making these contacts.

Finally, we have begun our OEA-R Membership Campaign. We have begun contacting people who are about five years from retirement to give them information about joining OEA-R before they retire. In the fall, we will be contacting former OEA members who have already retired but have not yet joined OEA-R.

None of this could happen without the involvement and support of many OEA-R volunteers. For that support, I say a heartfelt, Thank you!

# 2021 MAY OEA-R DELEGATE ASSEMBLY REPORT

The Virtual Delegate Assembly began at 10:04 A.M. on Thursday, May 6, 2021 with Chairperson, Mary Binegar, calling the meeting to order. There were 35 delegates present and between 7 and 3 guests throughout the meeting. The agenda was adopted with flexibility and minutes from the Virtual Fall Assembly were approved as printed.

Rita Walters presented the STRS Report. Ms. Walters reported the highlights from the April 2021 Board of Directors' meeting.

OEA President Scott DiMauro provided the delegates with an overview of what is to be expected at the OEA Virtual Spring Representative Assembly to be held on Saturday, May 8, 2021. There will be 4 New Business Items considered at the Representative Assembly. President DiMauro said that Ohio would be receiving \$4 billion over 3 years from the COVID Relief legislation that was passed. He explained that the legislation requires that the education community have input into how those dollars are spent. He also emphasized the importance of passing the Fair Schools Funding Plan.

Vice-President, Jeff Wensing, addressed the delegates thanking them for all their help with the current STRS Election. He also thanked the OEA-R delegates for their donations to the OEA Fund, formerly FCPE.

Secretary-Treasurer, Mark Hill, explained that this was an odd year for the budget so there will just be an update on the budget at the OEA Virtual Representative Assembly. He too thanked the delegates for all their help with the STRS Election.

Chairwoman Binegar introduced to Makia Burns, the new staff Liaison for OEA-R. Makia Burns introduced her administrative assistant, Chantelle Dixon who also will be working with OEA-R members. Makia has worked in the Organizing Department at OEA for the past eight years.

Dan Greenburg, NEA Director #5, provided the NEA Directors' Report. Dan reported that they are still meeting remotely with the legislators and that there are plans to resume in-person lobbying in October.

Judy Buschle reported on the NEA-R Grant. She reported that the OEA-R was very successful with their "Read Across America" activities, which was guided by Phil Long. OEA-R members were not allowed to go into the schools to read in person as had been done previously. Several volunteers videotaped the reading of a variety of books on diversity, and a library of those recordings is now available for use by active teachers. One of the goals for the grant had been to reach out and work with new educators and with aspiring educators. They have been able to do one activity with ONE but have not been able to have any activities with aspiring educators. Another activity that several members have participated in is a membership activity. Each OEA-R District Representative received a membership list. Each OEA-R member is listed by age. All OEA-R members 80 years old and more have been contacted either by a postcard, phone call or email. Just to let them know that we appreciate their membership and hope they are well. This offers us the opportunity to update the information on the membership lists and have them corrected. Judy Buschle also discussed a new way to reach out to active OEA members who are within 5 years of retirement to become lifetime OEA-R members by making payments. Mary Binegar and Phil Long have worked with OEA leadership to make this possible.

Tom Moscovic reviewed the screening process. Since all candidates were unopposed there was no need to screen. All candidates had completed the questionnaires and returned them. Only Dan Greenburg, running for re-election for NEA Director #5 and Mark Hill, running for re-election for OEA Secretary-Treasurer addressed the delegates. The OEA-R delegates endorsed all the

candidates. Makia Burns had generated an on screen ballot by which delegates could vote. Tom Moscovic also provided the most up-to-date figures for OEA-R delegate contributions to the OEA Fund (formerly FCPE). According to his information, which reflects all OEA-R contributions from September 2020 to May 4, 2021, OEA-R delegates had contributed \$6,519.25

Mary Binegar provided her report from the chair. She reviewed the many activities that OEA-R had accomplished over the past year. She commended the OEA-R members for all their diligent work on the STRS election. Members secured enough signatures to get Rita Walters and Bob Stein qualified for the ballot early in January This was not a small task because there were no in person meetings. Members also hand wrote over 8,000 post cards urging members to vote for the endorsed candidates. Once they were qualified then from the end of February until last week Mary Binegar, Phil Long and Rita Walters met with OEA leadership every Friday to work on the campaign. OEA provided complete support for the campaign for the three OEA endorsed candidates. Other activities have already been addressed in this report.

Carol Kinsey provided the OEA Board of Directors' Report. Because the delegate briefing was held prior to the Board meeting her information available was limited.

Jeff Corbin provided the checking account balance at \$4,713.79. Jene Wilson provided a report on the Resolutions Committee Report.

There were two new business items proposed. Proposal #1 offered recall language and proposal #2 offered language on appointments. Both proposals passed.

Mary Binegar recognized the following individuals for their service to the OEA-R Advisory Council because they have left either last spring or will leave this spring: Anne Bowles, Jeff Corbin, Jane Rahn, Sue Cramer, Peg Ham and Sandy Coe.

Carol Kinsey provided the delegate briefing.

### MAY 2021 OEA REPRESENTATIVE ASSEMBLY REPORT

At 9:00am Saturday May 8, 2021, OEA President Scott DiMauro gaveled 615 delegates to order for the OEA Spring Representative Assembly, held for the third time as a Webinar. Perhaps we'll get used to this form of meeting; there's a decent chance we'll assemble virtually at least one more time.

Early attendees were treated to music from the South East High School Jazz Band! After the normal greetings and introductions the assembled delegates got down to business.

There were candidates for four separate offices: Mark Hill, OEA Secretary/Treasurer; Dan Greenberg, NEA Director #5; Adrienne M. Bowden, NEA Director #6; Cassandra D. Daniels, OEA Board of Directors at-large. None faced opposition, so speeches were waived, and as such all were elected by acclimation.

A Proposal was put forth as follows:

To amend Article V Section 1(a) of the OEA Constitution to increase representation for Education Support Professionals (ESP) on the OEA Board of Directors to ensure that ESP representation on the OEA Board reflects the proportion of Education Support Professionals among active OEA membership.

Discussion brought out the fact that there has been one ESP Rep on the Board, for about 17,000 ESP members. The remaining Board members represent about 3,000 members each.

This proposal required <sup>3</sup>/<sub>4</sub> in the affirmative to pass. It received that and more. The Proposal passed. To obtain the ratio of 1:3000, the Board will add three additional ESP members. President DiMauro gave an impassioned speech in which he spoke for unified support of our actions in favor of the Fair Schools Funding Plan, now before the Ohio Legislature. This support is necessary in light of GOP legislative efforts to, among other things, grant educational vouchers to every single Ohio public school student (that is not a misprint). To emphasize the importance of unified action, President DiMauro aired an extended video of the history of our fight against Senate Bill 5, now ten years ago, from its introduction as an anti-collective-bargaining, anti-union bill by Ohio Senator Shannon Jones, to its signing into law by Governor Kasich, to the massive effort across the state to gather signatures for a referendum, to the campaign waged door to door against this bill, to its final defeat at the polls in November 2011. This video can be viewed on OEA's YouTube channel. Scott noted that nearly a third of present-day OEA membership has joined OEA since the defeat of SB5.

Also, The American Rescue Plan, recently passed by the US Congress, includes \$4.5 billion additional funding for America's schools, and the plan specifically notes that unions are among the stakeholders who must be consulted about how that money will be spent. OEA is sponsoring a series of "brown bag" meetings, beginning Monday May 10, during which Steve Dyer will present the various aspects and possibilities for the Rescue Plan funds. Links to these meetings will be emailed to members.

Patricia Collins Murdoch, the new OEA Executive Director, reported the addition of a 4<sup>th</sup> Strategic Priority: <u>Advocate for racial, economic, and social justice</u>. Also, a pilot coaching-mentoring program to produce an increase in the success of new teachers was presented. Pilot Pathways Program with Central State University to support minority candidates into the teaching profession.

Mark Hill, OEA Secretary-Treasurer, presented the Mid-Term Budget Adjustment 2021-2022. Highlights: there has been a reduction in membership as a result of Janus in 2018. The American Rescue Plan: \$4.5 billion to schools. We need to pressure the Ohio General Assembly to pass the Fair Schools Funding Plan. Average teacher salary calculation \$63,709. OEA dues tied into this figure. The complete report including graphs and tables is linked in the materials posted on the Web site.

Phil Long presented information on Kids Voting Ohio (<u>www.kidsvotingohio.com</u>), a new group encouraging Ohio young people to vote! Phil gave the same report to us at the OEA-R delegate briefing May 6!

The Resolutions Committee Report is linked on the Web site. Two new resolutions were proposed: one addressing the crisis in policing in Ohio, and one addressing voting rights in Ohio in light of nationwide attempts to restrict voting access. Chuck Steinbower, maker of these two resolutions, presented initial texts of these resolutions. After discussion, each was referred to the Resolutions Committee for wordsmithing and refinement. There was general agreement on the importance of these resolutions.

There were New Business Items introduced to rename the OEA Media Room the President's Board Room (amended to President's Meeting Room), and for the construction of an Honor Wall at OEA honoring all past OEA presidents. Discussion included an assessment of costs for each

of these. Both were subsequently referred to the Business Support and Administration Committee. Another New Business Item addressed the need for transparency in the newly named OEA Fund (formerly the Fund for Children in Public Education). Discussion included the need to know the specifics of how the funds are distributed, as well as how to educate members on why certain candidates receive funds. This NBI was referred to the Legislative Committee.

Toward the end of the meeting OEA was informed of the election to the STRS Board of one of the OEA-R endorsed candidates, Robert Stein. Our other endorsed candidate, Rita Walters, was not re-elected. Also re-elected to the STRS Board as an active member was Carol Correthers.

# **OEA-Retired 2021 FALL CONFERENCE**

The grant committee members, Judy Buschle, John Hoyes, Phil Long, Mary Binegar, and new staff liaison Makia Burns have been meeting and working towards completing our goals for the OEA/NEA 2020-2021 Grant. The following are the four goals we have been working on all year and an update of our progress.

#### I. To maintain and increase OEA-R membership
