During the Investment segment of the meeting Matt Worley reported that the total fund return for April was -4.03%. The preliminary 2022 total fund return is estimated at 0.11%. The capital markets reflect much uncertainty. Total investment assets ended April at \$91.6 billion, lower by \$3.2 billion in fiscal 2022. He provided the initial review of the Semiannual Broker Evaluation for the first half of fiscal 2023. The Board will vote on the recommendation in June. He also provided a review of the performance-based incentive program with a few minor changes.

During the Finance Department portion of the meeting representatives from Cheiron presented their economic assumptions for the June 30, 2022 Actuarial Valuation. STRS Ohio's current discount rate is set at 7.0%. Cheiron reported that at this time it is not recommending any change in the discount rate.

Gary Russell provided a pension benefit comparison with other teacher retirement systems in the United States. Specific comparisons to non-Social Security states: Alaska, California, Colorado, Connecticut, Illinois, Kentucky, Louisiana, Maine, Massachusetts, Missouri, Nevada, Ohio, and Texas.

Gary reported that statewide plans have been modified in 42 states since 2010 following the great recession, and typically the result has been: Increase years of service and/ or age for retirement eligibility Increase number of years used in the final average salary calculation Modify COLA.

No system is the best in all categories as:

-Contributions + investment earnings = benefits + expenses

-Illinois has the best COLA; however, 55% contribution rate and 42.5% funded

-Texas has the lowest contribution rate but also the lowest rated COLA -Nevada has largest benefit multiplier, but has never subsidized health care

STRS Ohio compares well among the 13 non-Social Security Systems

-Total contribution rate remains the fourth lowest of 14 rates

-Benefit increase or COLA's for a member retired 20 years is the sixth highest among the 13 states; the seventh highest for someone retired 15 years and the ninth highest for someone retired 10 years

-Retirement benefit as a percent of FAS, is near the midpoint for a member retiring with 34 years of service at age 56

-STRS Ohio is one of seven systems providing subsidized health care \$6.4 billion contributed to health care, is equal to \$50.9 billion pension asset value -Actuarial funded ratio is the third highest at 80.1% behind Missouri (87.7% and no health care), Maine (83.9% and no health care)

Eligibility for unreduced benefit is the key lever in most pension reform changes. Later age or more service is required of new members. Fourteen states require age 62 or older for unreduced benefit. Six states at age 62 (Louisiana, Texas and California). One state sets the age at 63. Five states require an age of 65 (Maine and Massachusetts) There are 18 states that require 30 years of service at any age for current year retirees.

Varied criteria for eligibility and amount of adjustment; however, no plan provides compounded COLA to match inflation.

Ten states have COLA's that are granted by the legislature. Eleven states have a compounded COLA. In 21 states if a COLA is granted it is a portion of the CPI. Some COLA's are based on performance on returns or funding level of the system. Arizona's COLA is based on excess returns over the last ten years. Idaho board can only pay a COLA if assets exceed liabilities after COLA is paid. New Jersey COLA suspended in 2011 until 80% funded (currently 40% funded). Wisconsin has a dividend adjustment that can increase or decrease benefit.

STRS Ohio total contribution rate is 12th lowest of 63 states. Average contribution rate for non-Social Security states is 32.10%, up from 31.96% last year. STRS Ohio member contribution rate is 18th highest of 63 states. STRS Ohio employer contribution rate is 6th lowest of 63 rates

After the last meeting the Board was notified that the ORSC had released its audit report. I am currently wading through the report and its recommendations. There was an article published by Gongwer and posted last Saturday. The gist of that article was that there were no signs of fraud found. The report by Funston was 279 pages. The article continued by saying that there was little evidence for many of the allegations leveled by critics of the pension system. The performance audit states that the board is legally required to balance the needs of current and future retirees when making decisions.

The report continues: "We recognize certain stakeholders will not be satisfied until annual COLA increases are restored. We also recognize the hardships retirees are experiencing, but the fiduciary duty of the Board is to ensure the sustainability of the fund for current and future members and beneficiaries"

In response to criticisms that STRS can be opaque, especially where private equity fees are concerned, the document states that PE fee transparency is an industry-wide challenge.

In response to claims that STRS investments have underperformed, Funston reached a different conclusion. The firm found that the STRS pension fund was in the top 25% when compared to peers and the "top performing" Ohio fund in the past decade.

The performance audit found that the STRS board, appears to have acted with "loyalty and impartiality" regarding its fiduciary duty.

When I finish the report and its recommendations I will report to you on those. Bottom line is that all of the lies that were put out by the other side during the election process were baseless and contrived to rile voters.

Beginning August 1, 2022, retirees and benefit recipients will start receiving the *Retiree Focus* newsletter and their payment stub two times a year.

The *Retiree Focus* and payment stub, which were previously mailed quarterly, will now be sent twice a year, once in January and once in July. Additionally, whenever there is a change to the benefit, a payment stub and an insert containing any necessary information will be mailed.

Retirees and benefit recipients will not receive a *Retiree Focus* or payment stub in September or December, but will continue to receive their payment each month. **This will not affect payments.** 

The *Retiree Focus* will still contain important information and dates, but will offer more comprehensive articles along with special features and savable cut-out sections, including the monthly payment schedule. It also will be available electronically as an email.

Retirees and benefit recipients will receive email updates in April and October containing SERS news.

### 2022 SPRING OEA-R DELEGATE ASSEMBLY AND OEA REPRESENTATIVE ASSEMBLY REPORTS

#### A Tale of Two Assemblies Part 2. May 5, 7, 2022

The single most striking moment of the OEA-Retired Delegate Assembly occurred near the end of our three-hour zoom Thursday March 5. At the conclusion of her Chair Report, Mary Binegar borrowed a phrase from fellow retired member Becky Brown and admonished the thirty-one Assembly attendees (and, by extension, all retired members) to, and I quote, "**Unleash the Beast!**" The Beast, it turns out, is our professional ire over the increasing number of critics of public schooling, more than a few from within our own ranks, including those who aligned themselves with the STRS Board candidates running against our endorsed candidates. More on those later.

All three officers joined our Retired Delegate briefing, and all brought their own versions of dire news, as well as some celebration. OEA President Scott DiMauro rued that so many teachers are leaving the profession that we are in a crisis, and then extolled the upcoming celebration of the 175<sup>th</sup> Anniversary of the OEA, taking place on June 4 in a tent outside the OEA Building. I figure there is information on that in other places on the Web site. Vice-President Jeff Wensing cautioned about the potential devastating results to education and schools were HBs 327, 322, and especially 616, to pass; all address to some degree or other the banning of teaching "divisive" concepts in schools. While "race" is featured prominently in each bill, "white supremacy" is not; you may draw your own conclusions. Jeff noted that a bright spot in the legislature is HB 497, which if passed will eliminate of the third-grade reading tests. Treasurer Mark Hill remarked that OEA is treading water in overall membership, down a half percent. Professional educator numbers have grown by a half percent, but there's a 3% drop in ESP ranks. OEA overall membership down about 7%. One possible reason offered is this is perhaps due to not being able to meet potential members in person these past two years. Mark is projecting a 2% membership loss for next year's budget; he hopes it is not that high, but we need to plan.

Judy Buschle reported on the NEA-R Grant: awarded \$9827, spent some of it. To date we have addressed all four goals in the grant, including aspiring educators and ONE.

Delegates heard speeches from candidates for statewide elections (because of problems with subs, not all candidates are here in person, some are, some recorded).

NEA Director #4 - Carol Correthers: here! (endorsed)

NEA Director #4 - Carol Nance: here!

Tom Moscovic gave the report of the screening committee, which had met on April 26. The committee had voted to endorse all unopposed candidates. They also had voted to endorse Angel Dyer Sanchez, and Carol Correthers. Our attending delegates voted to endorse the candidates recommended by the committee, and in fact, at the OEA-RA the next day, all our endorsed candidates were elected. Tom Moscovic also gave the Kickoff Report for the OEA Fund (formerly FCPE): Fund committee met on April 25. As of April 22 contributions: out of 8700+ OEA-R members, 55 members contributed. We need to get more members, and then more to contribute.

Chair Mary Binegar reported on the new OEA-R Racial and Social Justice Committee, which counts about a dozen members and has met via Zoom at least four times, with a fifth meeting scheduled Monday May 23. The committee, chaired by Jeff Corbin, will begin to research and conduct such events as webinars addressing various racial and justice issues, and will communicate these to all OEA-R members. The committee is in the process of creating a Logo, and a Facebook page. Members are also reading, collectively, <u>How to be an AntiRacist</u>, by Ibram X. Kendi. Any OEA-R member interested in joining the group may contact Jeff Corbin.

Mary will also introduce a NBI at tomorrow's OEA RA to reduce the annual dues for ESP members to OEA-R to half the current amount.

The delegates honored three of the OEA Retired Advisory Committee whose terms are up and are term-limited from seeking re-election: Carol Kinsey, Barb Catalano, and Wil Vickery. It goes without saying that we have been a better organization because of the contributions of all three of those friends and colleagues!

A fair bit of what we did Friday at our Retired-Delegate briefing was replicated at Saturday's OEA Representative Assembly, held both in person at the Columbus Convention Center, and virtually via whatever platform is used for such things. Approximately 350 delegates attended in person, and another approximately 350 delegates tuned in online. As noted, all the OEA-R endorsed candidates won their elections, which were conducted using new electronic hand-held devices distributed at the onset of the Assembly. In fact, these devices were used for all elections and decisions throughout the assembly, which gaveled down @9am and adjourned at @430pm.

I spent the first hour "personing" the Kids Voting table in the convention lobby on behalf of the good Mr. Phil Long, so I missed all that happened during that first hour, which as you can surmise were mostly introductions, preliminary reports, floor nominations, and so on. Frankly, we were all waiting for any announcement of the STRS Board elections, which would be made public at some point during the assembly. We were not to like the results.

Among various NBI and motions to pass were Mary's NBI, which she submitted as an individual and not on behalf of the OEA-RAC, to halve the dues of ESP members to OEA-R, and a change to the C&B to eliminate the opportunity of members to nominate candidates for any office from the floor of the RA. The latter change was debated for a while and passed by a few votes.

Toward the end of the meeting, during closing remarks, President DiMauro noted what everyone else had heard via assembly conversations and shared phone screens: all three OEA-Endorsed candidates for STRS Board seats had been defeated.

And, as we hear often at these Assemblies, that is my report.
