DECEMBER 15, 2022 REPORT

The meeting began at 8:00 A.M. with a meeting of the Audit Committee. Robert Vance, STRS Ohio's Internal Auditor provided an overview of the audit process. One of the recommendations of the ORSC Audit was to expand the internal auditing department of STRS Ohio. One of the Board members inquired if that recommendation was being addressed. Mr. Vance said they are working on it but the competition for auditors is very competitive and the availability is limited. Crowe is the External Auditing Company that performed the annual external audit of STRS Ohio. Crowe issued an unmodified opinion of STRS Ohio's financial statements. There were no significant deficiencies or material weaknesses identified.

There was an Investment Committee meeting after the Audit Committee meeting. An update was provided on the Investment Consultant Search. Evaluation of gualifying proposals will be provided in February. There was continuation of the discussion of investment beliefs. In February there will be a presentation of a set of beliefs and in March there will be presentation of the exact text.

The Callan Consultants presented a benchmark review summary. In early 2021 the Board conducted a thorough review of asset class performance benchmarks and adopted those indices currently articulated in the Statement of Investment Objectives and Policies (SIOP). It was adopted unanimously at that time. The summary of the Callan presentation is as follows:

*Active and passive is not typically an all or nothing decision- most institutional investors use a mix of active and passive strategies

*Each investor's mix of these approaches depends on their investment beliefs and goals for adding value above and beyond market-capitalization weighted indices. Investors need to consider not only the broader industry's successes with active management but their own organization's current and historical experience adding value.

*Like many other investors, STRS Ohio has had more success with active management in the less efficient asset classes like fixed income and international equity. In what is generally perceived as the most efficient asset class, Domestic Equity, STRS Ohio has had mixed success with both internal and external management but has recently made several changes to strategy to address this as discussed with the Board over the past seven years.

There was a discussion of Investment Beliefs: Active Management Discussion. Active Management

- * is widely adopted by pension funds in North America and Ohio
- * offers a wide range of strategies to increase STRS Ohio's expected returns
- * at STRS Ohio outperformed passive indices
- * increased STRS Ohio's market value by billions of dollars Investment beliefs interact: Diversification, Cash flows and Active Management

Matt Worley, STRS Ohio's CIO, opened the afternoon session with a report from the Investment Department. He asked for a motion to approve the Statement of Investment Objectives and Policy and Fund Governance (SIOP). That motion was approved with Mr. Fichtenbaum being the only dissenting vote.

Mr. Worley reported that the total fund rebounded in October increasing 2.97% and that Global Equity markets had strong returns: Domestic Equity (8.6%), International Equity (4.2%). The preliminary total fund for November was +3.97%. Strong returns continued as investors continue to evaluate economic policy and future growth. International Equity(9.2%), Domestic Equity (5.2%) and Fixed Income (3.5%). The preliminary fiscal 2023 total fund return is estimated at 2.64%. Total investment assets ended November at \$88.1 billion, higher by \$500 million in fiscal 2023.

CEM Investment Benchmarking Analysis for STRS Ohio for 5 year period ending December 2021. The key takeaways of the report are as follows:

Returns

*STRS Ohio's 5 year net total return was 12.4%. This was above both the U.S. Public median of 11.2% and the peer median of 11.9%.

*STRS Ohio's 5 year policy return was 11.9%. This was above both the U.S. Public median of 10.8% and the peer median of 11.5%

Value added

*STRS Ohio's 5 year net value added was 0.5%. This was above the U.S. Public median of 0.4% and equal to the peer median of 0.5%

Cost

*STRS Ohio's cost of 35.2 basis points was below our benchmark of 48.9 bps. This suggests that STRS Ohio's fund was low cost compared to our peers

*STRS Ohio's fund was low cost because it paid less than peers for similar services and it had a lower cost implementation style.

Through active management we have saved \$134 million. According to CEM STRS Ohio is a very cost effectively run system.

In October, the board approved new premiums for the 2023 plan year that resulted in lower premiums for about 95% of current health plan enrollees, along with a \$600 premium rebate for current enrollees. In 2023 a retiree with 30 or more years of service credit who is enrolled in the Aetna Medicare Plan will pay monthly premiums of \$31. It had been set at \$77, a \$46 a month savings.

Lisa Marshall of OEA-R also attended the meeting. The next regularly scheduled STRS Ohio Board meeting will be in February.

BALLOTS FOR EMPLOYEE-MEMBER SEAT DUE BY MARCH 6

ANOTHER TALE OF TWO ASSEMBLIES

OK, the title is a bit misleading. There were two delegate assemblies, one for OEA-Retired delegates at the STRS building December 2, 2022, and another for all OEA delegates, at the ought-to-be-renamed Kasich Center at the Ohio State Fairgrounds on December 3. The latter was gaveled in at 9am by OEA President Scott Dimauro and was adjourned well before 2pm by Mr. Dimauro. In between the approximately 660 elected delegates (down considerably from the nearly 1,000 delegates of, say, twenty years ago) were treated to various reports from various officers, much of which I will relate below. There were no elections, and no lunch break, and we were driving away by 2pm.

The OEA-Retired delegate briefing the day before proved to be highly informative toward the interests on retired members. Bill Neville, Executive Director of STRS, provided a detailed report on various aspects of STRS. There are 209 centenarians receiving STRS benefits, down from 216. How. There are 123 members at age exactly 99. The oldest benefit recipient is 110, and has been receiving retirement benefits since 1980. The longest benefit recipient has been receiving STRS benefits since 1957; She went on disability when she was 27 years old and is still receiving benefits.

Mr. Neville reported on the health of the pension plan: As of June 30, 2021, our defined benefit plan is 88% funded; without the changes in 2009, it would have been 57% funded. In 2008 the plan was 55% funded. This past year with bad returns (reported to all members in the recent STRS Newsletters) we are at 87% funded. In 2021, STRS was able to re-institute a 3% increase in the COLA. STRS also took away the age-60 requirement to receive full benefits. Mr. Neville reminded us the STRS oard does not have unfettered discretion to grant COLA; the actuarial manager has to approve any change. The CHEIRON study was found to be accurate and reasonable (as has since been widely reported in the newsletter and in various media). This report can be found on STRS Web site. Another study was a comprehensive assessment. STRS experienced a negative return last year, although the benchmarks were meant. Health care funding is solid; 93% of members will have lower premiums in the upcoming year.

There is blatant misinformation distributed about STRS. What can OEA-R do? On the STRS page is a resources tab. We must drill down to find it but look at how well the fund has been doing for a long time. Mr. Neville, in response to delegates' concerns, will try to make it easier to read and find. We all need to reissue this information. Is the way we pay PBIs the same or similar to the way it's done in other plans? They are paid on relative returns not absolute returns. Net of all costs and expenses only if we meet our benchmark. It is important to perform in a down year. Benchmarks are set by the Board annually. Board approves the bonus incentive, which is typical as a percentage of base salary of each individual. We have about 500,000 members/retirees, about 340,000 have email addresses. A delegate asked might we begin to use the emails to get out the word, instead of directing folks to web site.

OEA President Scott Dimauro reported on Secretary of State Frank LaRose's attempt to change the Ohio Constitution to require a 60% majority to amend the Ohio Constitution. This must be defeated! Enrollment in teacher ed programs is down 50%. 62% of present teachers report actively discouraging their own children from careers in education. Educator shortage!

OEA VP Jeff Wensing reported OEA has built a relationship with 50 of the 99 incoming state reps and senators. NEA director Dan Greenberg reported that the directors journeyed to Washington DC and lobbied for free-reduced lunch, the marriage equality act, and the elimination of GPO-WEP.

Mary Binegar gave the OEA-R Chair's report. OEA-R has made special efforts to contact members over 90. We received various responses, including from relatives of those who are no longer with us. We learned from our mailings of the passing of many members. OEA-R membership count is about 7200 members. Membership must be our key aim. We must work harder and more effectively too increase membership. We have come up with a membership plan that we'll work in conjunction with NEA. We'll try to set goals based on data, what works and what

doesn't work. Mary reminded delegates that every retiree gets a free one-year membership to OEA-R. Many don't know that; many don't renew after the year.


