May 2023 REPORT

The OEA-R members present at the meeting were Phil Long, Mary Binegar, Joni Watson, Jim McGreevy and me. Robert Davis was also in attendance. I was the only OEA-R representatives who spoke during public participation.

Chairperson Carol Correthers welcomed the new appointee for the Governor, Mr. Bishop. There were several signs all over the room posted by the ORTA group asking: "Where's Wade?" in reference to Wade Steen who had been the appointee by Gov. DeWine until May 5, 2023 when the governor's office announced that Mr. Steen's appointment had been rescinded and Mr. Bishop would be taking his place.

CFO Lynn Hoover began the meeting with a presentation concerning the Sustainable Benefit Enhancement Plan and other Updates. Ms. Hoover reminded everyone that Ohio law requires the Board's outside actuary to determine if a proposed benefit enhancement would materially impair the fiscal integrity of the system. The Board's pension funding policy complies with Ohio law, sets forth the goal of safeguarding members' benefits in the long-term and the funding objectives. The fiscal 2022 funded ratio is below its 100% funding objective and the 85% provision. No benefit enhancement is recommended by Cheiron, the board's outside actuary, at this time. The new Sustainable Enhancement Plan (SBEP) does all of the following:

*Complies with Ohio Law

*SBEP is designed to provide sustainability and manage the risk of future benefit cuts

*Plan can be utilized to augment the funding policy and scorecard assessment *Fiscal 2023 budget amount \$0; de minimis enhancement \$830 million *Board's pension funding policy will be reviewed by the board's governance committee; SBEP and framework can be included'

Mike Noble and Gene Kalwarski of Cheiron reviewed the presentation that Mike provided at the April Board Meeting. He also responded to questions that the Board had asked at the April meeting. Cheiron has determined that in the event the SBEP budget is zero, a de minimis enhancement would not materially impair the fiscal integrity of the system. The de minimis enhancement amount will be no more than 1% of the actuarial value of assets, provided the Plan is projected to be fully funded in 20 years or less after the inclusion of the de minimis enhancement.

*This projection will reflect the latest known investment return for the current fiscal year and assumed returns for future years

*FYE 2023 currently projected at 5%

A motion was made to pay a one time 1% COLA beginning July 1, 2023. Also to offer a temporary 34 year eligibility for unreduced retirement benefits. The motion passed but not unanimously.

Ms. Sellers had asked at the last STRS Ohio Board meeting in April for a comparison of the state's five pension systems. STRS Ohio's actuary, Brian Grinnell provided that review. STRS Ohio current funded status looks similar to SERS and OP&F, but results look very different if STRS Ohio paid an ongoing 2% COLA. According to the presentation the market value funded ratio is as follows: OPERS - 93.0%, STRS Ohio - 78.4%, SERS - 77.3% OP&F - 76.6%. The projected years to 100% funded ratio: OPERS - 6 yrs, SERS - 12 yrs, STRS Ohio - 13 yrs, OP&F - 18 yrs.

Matt Worley, STRS Ohio CIO, reported that the Board had been working on developing a Statement of Investment Beliefs which was one of the recommendations from the Fiduciary Audit. There was a motion to approve the Statement of Investment Beliefs which passed but not unanimously. According to Mr. Worley the preliminary total fund return for April was +0.86%. The preliminary fiscal year 2023 total fund return is estimated: Gross return +5.29%, Net Return +5.19%. Total investment assets ended April at approximately \$88.7 billion; higher by \$1.0 billion in fiscal year 2023.

An initial review of the performance-based Incentive (PBI) Policy was provided by a representative from Aon McLagan. STRS wants to insure that the Plan will:

*attract, motivate, and retain top caliber professionals

*Provide competitive pay that balances internal equity with market competitiveness

*Drive exceptional long-term investment performance with appropriate levels of risk and cost

*Be fair, reasonable, and relatively easy to understand and administer. McLagan found that the Plan is generally aligned with competitive market practice. For example, the plan does the following: *Includes staff who have direct impact on results or perform analysis that facilitates portfolio decisions.

*Includes incentive maximums that vary by position.

*Includes a mix of short- and long-term performance.

*Rewards participants for value-add over policy benchmarks. However, McLagan recommends STRS consider making some or all the following changes:

*Measure all investment performance net-of-fees. (currently, there is a mixed use of net and gross Increase the minimum weighting to total fund performance from 10% to 20%).

*Simplify the plan by removing one-year measures from portfolio and asset class components (currently weighted at 2-10% of total incentive opportunity). *"Clean-up" the plan document by ensuring plan provisions are clear and precise.

*Move administrative policies into a separate document.

*Adjust the absolute return provision to be a linear gradient (e.g., haircut equal *Institute a 1x positive return adjustment in positive years.

I hope more and more OEA-R reps attend the STRS Ohio Board meetings. You will understand what we are up against.

THE TALE OF TWO ASSEMBLIES

The OEA-R Delegate Assembly convened for its spring meeting at STRS on Thursday May 11, 2023. There were thirty-four delegates and twelve guests in attendance. As anyone who reads this knows, our gatherings have always been informed and enlightened by the active questioning and wisdom of Bill Dorsey. To say that his absence at this meeting was noticed is an understatement. We all learned plenty from our various speakers, and many of us asked good questions of clarity of our guests and officers. But let's face it; none of us is going to bring the insights Bill always brought. He is missed.

We sat for "unprepared" remarks and a short Q&A with STRS Director William Neville. He was not able to talk about the recent election of Pete Davidson to the STRS Board, taking the seat of the OEA-endorsed candidate and incumbent Arthur Lard. SB 6 would allow "retired reemployed" to serve on STRS Board, if the bill passes. There have been twenty-seven various allegations against STRS, and all have been found to be without merit. The STRS budget will increase 2.7%. Regarding PBIs (performance-based incentives), or bonuses paid to various STRS employees, Mr. Neville noted that only those making investment

decisions are eligible for these. PBIs are rewarded to those who beat boardapproved benchmarks. There are no subjective components. The Board can grant a Cost of Living Adjustment to annual pensions only if the outside auditor (Cheiron) offers the judgment that doing so would not materially IMPAIR the INTEGRITY of the asset. As we all know, last year the Board approved a 3% COLA (as of 7.1.22), and this year has just approved a 1% COLA, as of 7.1.23.

The Assembly heard remarks from the OEA President Scott DiMauro. His big theme: How and why public education matters. Public education is under more of a threat than it ever has been. Fear, division, book bans, harmful legislation, supporting a privatization agenda, expansion of private school vouchers are all affecting our profession. We're all in the business of helping students become good citizens, and not merely good workers supporting the economy. **We need to strongly vote against the ballot issue moving the constitutional change to a 60% vote. No minority-rule! No 40%+1!** Scott addressed Mr. Lard's loss. OEA invested heavily in the campaign, conducted lots of research, conferred with consultations, and ran a stellar candidate. There seem to be two problems: 1. lot of folks who don't understand basic issues about retirement: pensions, retirement security, relations to legislatures; 2. we are up against a wave when it comes to our members, in their dissatisfaction with what has been happening at STRS.

OEA Vice President Jeff Wensing reported about HB1. Among the various facets of this bill is the attempt to change our tax code toa flat tax of 2.75% across the state. This would cost \$4 billion in lost revenue, affecting local governments as well as school districts. Makers of this bill actually have backed off, but the bill is still there. A small bit has been incorporated into budget bill, HB 33. The two universal voucher bills are HB 33 and SB 11. HB 33 increases the income-based voucher to 400% of poverty to be eligible. The estimate is that for current students in private schools this would cost over \$500 million and does not count new students. Vouchers would later cost \$1.1 billion. Remember that these vouchers are available not only to student in public schools who wish to transfer to private schools, but also to students who have always attended private schools and never attended public schools, ever.

The delegates, on the recommendation of the screening committee, endorsed the candidacy of Amy Butcher for the office of NEA Director #2. (She was subsequently elected at the OEA-RA two days later.).

Bill Lavezzi reported that he will propose the following New Business Item at the Representative Assembly: OEA Government Relations will identify the names and electoral units of all Ohio legislators who voted in favor of legislation changing the vote required to amend the Ohio Constitution to 60%. OEA Government Relations will identify the names and electoral units of all Ohio legislators who voted in favor of legislation placing the issue on the August 2023 ballot. This information will appear in Ohio Schools and will be made available to OEA Fund meetings, including local screening councils, until the date of the spring 2026 Representative Assembly. Bill's point, shared by all delegates, is that we need to begin to hold these legislators accountable for their actions and decisions that run counter to the needs and the will of the people of Ohio, and most certainly of our members.

The OEA Spring Representative Assembly convened Friday May 12, beginning at 6pm, recessed at @8pm, and reconvened the next day, May 13, @9am. Here I must report that I was unable to attend the Assembly due to a small but significant medical issue. So, what follows comes directly from the thorough report of Deloris Rome Hudson, the OEA-Retired Rep to the OEA Board of Directors. Deloris! Thank you so much! Here it is:

- 3. Approved the proposed 2023-2024 Resolutions Report, as amended.
- 4. Passed the following New Business Items:
 - SP-2023-01 The Representative Assembly adopts the OEA Vision Statement as recommended by the Board of Directors: To create an Ohio where every student has access to a high-quality public education and where all members are supported, valued, and respected.
 - SP-2023-02 The Ohio Education Association will provide the necessary budget and staffing support to carry out the action plan created by the Education Support Professional Educator Voice Academy. Specifically, the Educator Voice Academy actions will need staff and budget support to organize activities including but not limited to: Reaching out to ESP members at OEA meetings over the summer to raise awareness and gather support for a movement to increase wages and build respect for ESPs Conducting 1:1 conversations with ESP local leaders Organizing a meeting of ESP Presidents with the goal of getting member voice and state approval to build membership and power Organizing local listening meetings to gather member input Creating an ESP specific page on the OEA Website
 - SP-2023-03 The OEA Representative Assembly endorses the recommendations of the OEA Educator Voice Academy Cadre on Social and Emotional Learning. Specifically, OEA's EPRMA Department will develop bargaining guidance that promotes the

inclusion of OEA members as active participants in the selection of Social and Emotional Learning curriculum, advocates for continued professional development that supports the effective implementation of that curriculum and requires OEA members to be partners in the development of a social and emotional learning curriculum implementation timeline at the local level. Bargaining guidance would provide a starting point for contract and/or MOU language that supports OEA member inclusion in these processes. Recommended actions include: OEA staff locate, curate, and host links to and titles of available social and emotional learning resources for OEA members. OEA should develop and facilitate professional development and advocacy opportunities that stress the importance of educators prioritizing their social and emotional needs. OEA should support member-developed and member-led professional development opportunities focused on social and emotional learning curriculum and implementation.

- SP-2023-04 The Representative Assembly endorses the OEA Public Education Matters initiative, and in support of building a movement to protect, defend, and strengthen public education in Ohio, the Ohio Education Association shall conduct a mass solidarity event in Columbus for members and allies in the Fall of 2023.
- SP-2023-05 OEA Government Relations will identify the names and electoral units of all Ohio legislators who voted in favor of legislation changing the vote required to amend the Ohio Constitution to 60%.OEA Government Relations will identify the names and electoral units of all Ohio legislators who voted in favor of legislation placing the issue on the August 2023 ballot This information will appear in Ohio Schools and will be made available to OEA Fund meetings, including local screening councils, until the date of the spring 2026 Representative Assembly. Here is Bill Lavezzi's NB item!
- SP-2023-06 OEA will investigate the feasibility and benefits associated with creating cohorts similar to Ohio's New Educators (ONE) with Member Ambassadors who can focus on the personal and professional needs of educators in the middle years and the final 10 years of their career and report the findings to the Representative Assembly in Spring 2024.
- SP-2023-07 In order to increase the involvement of all OEA members a special members column or forum should be a regular feature in Ohio Schools Magazine.
