

OEA Campaign 2018 OEA-R/NEA-R Members CAN Make a Difference OEA Campaign 2018 is now in active mode. OEA-R/NEA-R members are requested to become involved!!! There are several options for OEA-R involvement in this Campaign but THE ONE option that every member can exercise is to **VOTE!** There is

absentee voting, early voting, or voting in person at the polls on November 6. There are opportunities to become involved in individual Campaigns by contacting the candidate's campaign directly or the Party Chairperson in your County. Sharing information about OEA endorsements with family and friends is a powerful option. Educators are often looked to as informed sources of who will best serve PUBLIC EDUCATION. It is key in these challenging times to remember that OEA endorsements are made on the basis of who will best serve the interests of PUBLIC EDUCATION, not necessarily other issues which members may have strong personal opinions about. VOTE your profession (which in turn helps strengthen STRS). If you are having a group event with at least 30-50 people at your gathering, you can contact OEA President Becky Higgins with a request for Rich Cordray or one of the other statewide candidates to attend your event. The request does need to go through Becky and would be dependent upon the candidate's already committed schedule.

All statewide candidates for the 2018 election were invited to screen with OEA. Local House and Senate District screenings are currently taking place with all candidates invited to participate. There are a few State School Board seats to be elected this year and those screenings will take place after the nonpartisan filing deadline on August 8. Be sure to check your Election Issue of Ohio Schools for a comprehensive listing of all OEA endorsed candidates.

Incumbent **US Senator Sherrod Brown** was screened in Columbus on September 30, 2017 and received an NEA Endorsement in early October 2017. (One other candidate in that race screened with OEA)

The OEA FCPE State Council met on March 9-10 to screen statewide candidates with the exception of Gubernatorial candidates, as there were contested primaries for those nominations and judicial candidates. On March 10 the OEA FCPE State Convention approved the following State Council recommendations:

Attorney General-----Steve

**Dettelbach** (Candidates from both parties did screen)

Auditor----Zach Space (only Mr. Space screened)

Secretary of State----Kathleen Clyde---- (Candidates from both parties did screen)

**Treasurer----Rob Richardson**----(only Mr. Richardson screened)

On May 18-19 (post Primary) the OEA FCPE State Council screened the Gubernatorial Candidates and Ohio Supreme Court Justice candidates. The OEA FCPE State Convention approved the following recommendations on May 19:

**Governor----Richard Cordray** (Only Mr. Cordray screened)

For **Ohio Supreme Court Justice** beginning January 1, 2019 **Michael P Donnelly** was endorsed (both candidates did screen) For **Ohio Supreme Court Justice** beginning January 2, 2019 **Melody J Stewart** was endorsed (both candidates did screen)

I represented OEA-R/NEA-R during each of these screenings as the OEA-R Alternate while our OEA-R FCPE Representative Pam Smith continues to recuperate. OEA-R had a voice for all Statewide Screenings.

As of June 8, 2018 OEA records indicate there are 9,228 OEA-R/NEA-R members but only 112 have contributed financially to OEA FCPE. Between September 1, 2018 and June 8, 2018 those 112 members have contributed \$14,390.00 for an average of \$127.86 per contributor. If every OEA-R/NEA-R member contributed \$15 we could raise well over \$100,000 just from OEA-R/NEA-R!!!! # STRS

At the May STRS Ohio Board of Directors' meeting the Board interviewed four Actuarial firms that returned RFP's. Our contract with Segal has expired and we needed to either rehire Segal or change to another firm. The four firms that returned RFP's were GRS Retirement Consulting, Milliman, Cheiron and Segal. Each firm had thirty minutes for its presentation. The Board reached a consensus decision and authorized Mr. Nehf to negotiate a contract with Cheiron.

Mr. Nehf reported that after a 33-month project, STRS Ohio staff and vendor successfully upgraded the STaRS pension fund management system to version 10 from version 8.3. The new software went into operation on May 8. The project required a sustained commitment from staff from multiple STRS Ohio departments, as well as a large contingent of contractors from Vitech, Inc. While the upgrade was implemented six months later than originally planned, it was completed within budget. The STaRS system enables all necessary pension fund management functions, such as maintaining member information, accepting contributions from employers, paying monthly benefits and providing health care benefits. The Member Self Service (MSS) and Employer Self Service (ESS) secure web portals are also part of the STaRS system and were upgraded. STRS Ohio now operates on the latest version of Vitech's software. Staff anticipates operating on version 10 for about five years before another upgrade project will be necessary.

April was another good month for both absolute and relative investment performance. The investments are at approximately 8.7% for the fiscal year to date for 2018. The preliminary STRS Ohio total fund return for the month of April was 1.0%. Investment assets increased in April to an estimated \$77.7 billion from \$77.3 billion at the end of March and \$75.1 billion at the beginning of the fiscal year 2018.

Rob McFee and Jeff Rhodes won their election to active seats on the STRS Ohio Board of Directors. They will begin their terms on September 1, 2018. Tim Myers will be retiring on June 1, 2018. That means that May was his last meeting to serve on the STRS Board. In April, the Speaker Pro Tempore of the Ohio House of Representatives and the President of the Senate jointly appointed David Gruber to an investment expert seat on the Retirement Board. Mr. Gruber is the director of Risk Advisory Services for Holbrook & Manter, CPA's. The term for this seat runs through Nov. 4, 2020.

The STRS Ohio Board approved the Health Care Premiums for all plans offered through the STRS Ohio Health Care Program for 2019. A complete list of these premiums is posted on the system's website or may be obtained by calling the toll free number 1-888-227-7877. About 92% of plan enrollees will have 2019 health care premiums equal to their 2018 premiums. Approved dental and vision plan premiums for 2019 are essentially unchanged.

The STRS Ohio Board of Directors also voted to extend the Medicare Part B Reimbursement for one year. Under this program, benefit recipients currently enrolled in the STRS Ohio Health Care Program and Medicare Part B receive \$29.90 per month to reimburse a portion of the Medicare Part B Premium. About 85,000 benefit recipients receive this reimbursement that was set to be reduced to \$0 beginning Jan. 1, 2019.

#### SERS

Russell Investments presented an education session for the Board regarding SERS' tactical asset overlay program. SERS has been a client of Russell Investment for more than 25 years, but only began the tactical overlay program three years ago. In that short time period, the program has added more than \$30 million in excess investment returns to the Total Fund.

The overlay program is not an allocation but an active management strategy within SERS' existing asset allocation. While SERS' staff continues to manage assets in the portfolios, Russell is given the discretion to increase or decrease up to 4% of equity and bond positions based on the economic conditions to maximize investment returns. SERS' CIO, Farouki Majeed, said that an added bonus of working with Russell is that staff receives insight into its processes, which helps staff better manage its portfolios.

#### **Investments Quarterly Report**

Wilshire Associates provided the Board with an update of current investment conditions in the U.S., and SERS' third quarter investment results for FY2018.

Despite the stock market being slightly down for the quarter, Lindberg noted that the U.S. economy remains strong with good jobs reports, inflation at the Federal Reserve target, rising wage growth, and continued borrowing by households.

Wilshire addressed the concern that the current economic cycle is nearing its end and the U.S. is heading toward a recession. She pointed to signs that growth has peaked: inflation is beginning to rise, and the Federal Reserve tightening monetary policy as indicators that a recession is becoming more likely.

SERS' investments continued to perform well when compared to all other U.S. public pension funds. Despite a quarter where the U.S. stock market was down -0.76%, SERS' Total Fund gross-of-fees gain of 0.79% ranked 9th in the nation. Over one year, SERS' 13.03% gain also ranked 9th nationally, its three-year return of 8.54% ranked 4th, and its five-year return of 9.32% ranked 13th. These were unprecedented numbers for SERS' investment returns.

#### Health Care Update

SERS presented the 2019 proposed rates for SERS' self-insured medical plans and prescription drug coverage. Bennett discussed the impact on the proposed rates of various recommendations for benefit changes. She also suggested that the Marketplace Wraparound and early Medicare programs initiated by the Health Care Department, along with the prescription drug Marketcheck and favorable Medicare Advantage rates likely will lower premiums and bring health care costs down in the coming year.

Proposed changes to the Medicare medical plan design included decreasing specialist office visit co-pays to \$30; increasing chiropractic co-pays to \$20; and changing the ambulance benefit from coinsurance to an \$80 co-pay. Proposed changes to the non-Medicare medical plan design included a change to the emergency room benefit from coinsurance to a \$150 co-pay.

Dental and vision rates also were disc used. The proposed dental rates for 2019 increased from \$27.81 to \$28.09 for benefit recipients; \$55.62 to \$56.18 for benefit recipients and one dependent; and from \$83.70 to \$84.54 for benefit recipients and two or more dependents. The proposed vision rates for 2019 remained the same with \$7.11 for benefit recipients; \$14.22 for benefit recipients and one dependent; and \$16.70 for benefit recipients and two or more recipients.

## Monthly Retirement and Survivor Benefit Transactions

For May, the SERS Board approved 538 active members for service retirements, and 19 survivor benefits for spouses and/or dependents.
